Workers Adjustment and Retraining Notification (WARN) Act: WARN requires to notify all affected employees, employee representatives, NYS Department of Labor, and Local Workforce Investment Board 90 days notice prior to a plant closing, mass layoff, relocation, or reduction in works. The State WARN Act applies to private sector employers with 50 or more full-time workers and affects 25 or more employees.
